#### **REQUIRED DOCUMENTATION**

- DISCIPLINE RECORDS – Must have no suspension, expulsion, DAEP, or history of persistent disciplinary problems.
- ATTENDANCE RECORDS – Must have 96% or greater attendance rate.
- REPORT CARDS – Must have 75 or higher semester average in all classes.
- STATE ASSESSMENT RESULTS (STAAR, EOC, TELPAS) – Must have passed all state assessments.

#### **NOTICE REGARDING FALSE INFORMATION**

Ferris ISD is required to inform persons enrolling a student in the district that:

- Presenting false information or false records for identification is a criminal offense under Penal Code 37.10 and that enrolling a child under false documents makes the person liable for tuition or other costs as provided in Education Code 25.002(d).
- A person who knowingly falsifies information on a form required for student enrollment in the district shall be liable to the district if the student is not eligible for enrollment but is enrolled on the basis of false information. For the period during which the ineligible student is enrolled, the person is liable for the maximum tuition fee the district may charge or the amount the district has budgeted per student as maintenance and operating expense, whichever is greater. (Education Code 25.00(h)).
